

Temple Beth Shalom Children's Center Summer Fun Program 2009



The Summer Fun program is designed for children 2 (Must be 2.0 by 6/1/09) 3 and 4 years of age, on Tuesdays, Wednesdays and Thursdays from 9:00 a.m. to 1:00 p.m. Families can choose from 2, 4 or 6 week sessions for their children. During this time, children will have the opportunity to play, explore, sing, read, create and learn with one another, teachers and counselors; indoors and outdoors.

Our staff will consist of three Lead-Teacher-Certified teachers along with high school and college counselors. Each session will be open to 24 children. Of these available spaces, according to State Regulations, we will be able to accept up to nine toddlers (2.0 to 2.8 years).

A mid-morning snack will be provided. Children will bring their lunch to Summer Fun. We are a **“peanut butter and nut free”** building. It is our policy that children who have any allergies, including nut, soy, wheat, egg, milk, and others, bring their own snacks in labeled baggies to Summer Fun each day.

Dates: June 30 – August 6, 2009 (Tuesday-Thursday each week (6 weeks))
Hours: 9:00 a.m. to 1:00 p.m.
Registration: Registration forms, with registration fee, are being accepted beginning February 2, 2009. Applications will be accepted as space is available, based on the application procedures as explained below.

Priority will be given to children in the following order, based on a first come, first serve basis within each category and based on all TBS and TBSCC fees and dues being paid and current:

1. Children currently enrolled in the Children's Center
2. Children accepted for admission in the Children's Center for Fall 2009
3. Temple members' children
4. Siblings of current families
5. Community at large

Tuition is non-refundable. If your child should not attend the program for some reason, you would forfeit the tuition paid for the registered sessions. No reduction of fees or tuition will be made for absences or withdrawals. All policies that govern the Children's Center will be in effect for the Summer Fun program.

We will notify you that your child has been placed on a waitlist should the interest in the program outweigh the number of spaces available.
